เรื่อง การประกวดรางวัล Asia-Pacific Child Rights Award for Television 2011

เรียน พอ.สท. และ พอ.สปช. ๑ - ๔

ด้วย ABU ร่วมกับ CASBAA และ UNICEF ได้จัดประกวดรายการโทรทัศน์เพื่อรับรางวัล Asia-Pacific Child Rights Award for Television ประจำปี ก.ศ. ๒๐๑๑ โดยเปิดโอกาสให้ผู้ผลิตรายการ โทรทัศน์ในเอเชีย-แปซิฟิก เข้าร่วมในการประกวดนี้

รายการที่ส่งเข้าประกวดจะเป็นรายการที่ผลิตสำหรับเด็ก หรือรายการที่มีเนื้อหาเกี่ยวกับเด็ก ก็ได้ รูปแบบของการอาจเป็นสารคดีที่ให้ข้อมูลเกี่ยวกับสภาพความลำบากของเด็ก หรือละครที่ช่วยลบล้างความรู้สึกดูหมิ่นหรือการแบ่งแยก หรืออาจเป็นการตุนที่ให้ความรู้หรือให้ความบันเทิงก็ได้ เช่นกัน แต่จะต้องออกอากาศระหว่างเดือนมิถุนายน ๒๕๕๓ - พฤษภาคม ๒๕๕๔ และต้องส่งถึงองค์กรยูนิเซฟ ภายในวันที่ ๑๕ มิถุนายน ๒๕๕๔ (สำนักงานตั้งอยู่ ณ กรุงเทพฯ) ทั้งนี้ การตัดสินจะพิจารณาทั้งคุณภาพการผลิต และการถ่ายทอดเนื้อหาเรื่องราว สำหรับพิธีมอบรางวัลจะมีขึ้นต้นเดือนพฤษภาคม ๒๕๕๔ โดยผู้ชนะจะเดินทางไปรับรางวัลในระหว่างการประชุมของ CASBAA ที่ยังคง



## Asia-Pacific Child Rights Award for Television 2011

The ABU, CASBAA and UNICEF are calling on Asia-Pacific broadcasters and producers for entries for the 2011 Child Rights Award.

The award is given each year to the best television programming on children's rights produced in the Asia-Pacific region. It recognizes the efforts of broadcasters in pursuing both the production of good-quality children's programming and better coverage of children's issues.

Programmes both for children and about children are eligible and can cover any children's rights issues. Entries can include documentaries that detail the plight of children, dramas that help break down stereotypes and discrimination, or animation that teaches and entertains. Entries must have been broadcast between June 2010 and May 2011 and **must be received by 15 June 2011**. The award will be presented during the CASBAA Convention in early November 2011. The winner will be flown to Hong Kong for the ceremony.



## TELEVISION AND CHILDREN

Children in nearly 90 per cent of homes in Asia and the Pacific watch two to five hours of television per day. Without a doubt, television plays a significant role in shaping children's social and emotional development.

Broadcasters from the region attending the Asia-Pacific Television Forum in Seoul in 2001 discussed the role of this influence and pledged to pursue children's programming that is both of good quality and sensitive to children's issues. Because of that industry commitment, the ABU and CASBAA teamed with UNICEF to launch a Child Rights Award that honours individual broadcasters' follow-through on their pledge.

## CHILDREN'S RIGHTS

The Convention on the Rights of the Child (CRC) turned 20 years old in 2009. It was adopted during the United Nations' World Summit for Children in which world leaders agreed to recognize and protect the rights of children. The Convention has achieved near-universal acceptance, having now been ratified by over 190 parties – more than belong to the United Nations or have acceded to the Geneva Conventions.

The CRC spells out the basic rights that apply, without discrimination, to all children. In so doing, it defends their right to:

- survival
- develop to the fullest
- protection from harmful influences, abuse and exploitation
- participate fully in family, cultural and social lives.
