AIBD เชิญ กปส. ส่งบุคลากรเข้าร่วมการประชุม จำนวน 1 คน โดย AIBD จะรับผิดชอบค่า โดยสารเครื่องบินชั้นประหยัด ค่าที่พัก ค่าเดินทางไป-กลับจากสนามบินจาการ์ตามายังโรงแรมที่พัก และค่า วัสดุอุปกรณ์ต่าง ๆ โดย กปส. จะต้องรับผิดชอบค่าเบี้ยเลี้ยงของผู้เข้าร่วมประชุม

Re: AIBD/FES Regional Workshop on Media and Elections 19-23 November 2007, Kuala Lumpur, Malaysia

Greetings from AIBD!

We are pleased to inform you that AIBD and FES are organizing a Regional Workshop on Media and Elections. Participants will be Radio and TV broadcasters from 10 countries in Asia-Pacific. The workshop will be held from 19-23 November 2007 in Kuala Lumpur, Malaysia.

The five-day workshop aims to build capacity of broadcast journalists in practicing good journalism on elections. Participants will also share cross-case comparative insights on election reporting in the region and learn from best practices on election reporting. The workshop consultant is Dr. Venkat Iyer, a media law and elections expert and media editor, originally from India, and now works with the University of Ulster, UK.

This workshop will provide theories, case studies and practical exercises for a deeper understanding of good reporting for broadcasters. It will be more interactive to optimize participation and the learning process.

Issues to be covered

General

- The media as the "Fourth Estate" and its role during elections
- · The 'watchdog' role of the media
- · Censorship during elections and ways of avoiding/combating it
- Physical attacks on journalists and ways of avoiding/combating it
- Access to information during elections



- · Need for media pluralism and for diversity of sources of information/news
- · Balancing the rights of voters, candidates and the media

Particular attention will be given to the functions of the media during elections, including:

- Educating voters about democratic rights
- Providing candidates and political parties with a platform for debate
- Enabling candidates and political parties to communicate with the public
- Monitoring and reporting on the fairness of the election process
- · Reporting the election results fairly and promptly

Specific

- Balancing transparency on the part of election commissions with the need for such bodies to maintain a degree of confidentiality to ensure the integrity of the electoral process
- · Ensuring freedom from "spin doctoring" by candidates, political parties and others
- Embargoes and the internet
- · Covering "hate speech" during election campaigns
- Allocation of broadcasting time for candidates and political parties
- Regulation of advertising by candidates and political parties
- Impartial and fearless coverage of issues relevant to an election
- Training needs and methodologies in election coverage (including imparting of knowledge of electoral systems and processes, key election laws and regulations, the country's history of electoral democracy, etc.)
- Logistics of election coverage (geographic spread, efficient use of scarce resources, etc.)
- Mechanisms and procedures for the prompt correction of factually inaccurate statements that have already been published
- Conduct and reporting of opinion poll results
- Conduct and reporting of exit poll results
- Coverage of election counts
- · Particular responsibilities of publicly-owned media
- Journalists' access to information
- · Journalists' right to keep their sources confidential
- Media's relationship with election commissions and other election management bodies
- Media alertness to 'planted' stories during elections
- · Coverage of election rallies and other set-piece events
- Ethical issues in election coverage

Participants will be 20 TV and radio journalists from Bhutan, Brunei, Bangladesh, Cambodia, Indonesia, Malaysia, Sri Lanka, Thailand and Vietnam. The proposed list of participants should be gender balanced. They should have 4-5 years experience in radio and TV journalism and should have more than average command of English.

We are glad to offer one place for a qualified journalist from your organisation. The nominating organization is requested to nominate a principal and an alternate candidate. Place are offered strictly on a first-come first served basis provided all

conditions and requirements are met. Your applicants must include at least one female journalist. The candidates should fill in the required application form (attached) and send it to the AIBD.

As a further cost cutting measure as well as a manifestation of collaborative effort, expenses are to be defrayed as follows:

- The organizers will provide an economy return air ticket, accommodation, all materials, local transportation and other facilities for the workshop.
- Nominating organizations will meet the cost of daily subsistence allowance, excess luggage, transportation costs to and from the airport handling charges, extended days of transit, unauthorized stopovers/charges to itinerary for their respective participants.

Nominated candidates are expected to be in positions whether they can usefully employ the knowledge and skills acquired during the activity or they should be able to return to positions where they can do so.

Please note that the organizers will not accept any responsibility for incidental expenses associated with selection, travel or compensation in case of sickness or accident during the period of the activity. Candidates or their organizations are advised to take adequate measures to cover against this.

Application forms must be sent to AIBD before Thursday 20 October 2007.

- Project presentation, which includes the objectives and workshop content
- The application form, which includes the conditions for the participation, the obligations from the organizers, the candidate and his/her broadcasting organization.
